

Copyright is designed to encourage others to build on the ideas and information of a given work while protecting an author's original expression. Copyright protects a range of materials, including books, articles, photographs, paintings, sculpture, software, websites, architecture, and music. Copyright applies to any "original work of authorship" that is "fixed in a tangible medium of expression." Works are protected automatically; copyright notice or registration with the U.S. Copyright Office on the work are not required for protection, though notice does provide some legal and practical benefits. OPTIONS FOR SHARING COPYRIGHTED INFORMATION WITH YOUR STUDENTS

- Link to an article or web page directly rather than reproducing it on your website. This [handout](#) [pdf] explains the process of linking directly to a full-text article in one of the library's databases. You can link directly to a resource on your own website or in [Blackboard](#).
- Use the Monroe Library's electronic [reserves](#) service. Articles, class notes, and selected book chapters can be made available to Loyola students through this service.
- Faculty may also place physical materials, such as books, class notes, videos, and sound recordings, on reserve in the library for their courses. All requests must contain a complete citation. For more information, contact Evonne Lawrence at ekelly@loyno.edu or 864-7165.
